4. Fire Department new hire- Captain Morrow and Chief Nelson asked the board to hire Jordan Williams for the position of Part-Time paid on-call. Jordon works at MATES as an electronics specialist. He has EMS experience and looks to helping his community. He has been in the Army Nation Guard for the past 17 years. Start immediately at a pay rate of \$12.00 per hour. Motion by Treasurer Witnee Rose to Hire Jordon Williams with Support from Clerk Sandy Beaudet. All Ayes, motion carried.

## Reports:

- 1. Fire Department. Was read by Dan Bonamie.
  - The Fire Department has had 15 runs including 1 Mutual Aid Structure Fire to the city of Grayling
  - Chief Nelson has begun working on the budget for the 2024 budget year. More to come on that as chief Nelson irons out the details.
  - A request was sent to the board on March 4<sup>th</sup> to Hire Jordan Williams as a part time/Paid on Call firefighter. Jordan brings a wealth of knowledge, including EMS experience.
  - A New Fire Department training plan is being developed and to be implemented as soon as it is completed.
  - New SCBA's are in service
  - The Fire Department received some new turnout gear from an anonymous donor. The gear is brand new and outfitted 4 firefighters.
  - Beaver Creek Fire Department was included in a regional AFG grant to secure new radios as the radios we currently have will be outdated and as they age new parts will not be available. BCFD will be receiving 10 new handhelds if the grant is approved. Cost to the department is 5% of our cost, roughly \$3,000. Final numbers will be worked into the new budget.
  - Other grants have been applied for and we will keep the members of the board and its citizens updated as the final decisions come in from those. These include grants for gear and equipment.
- **2. Supervisor Report.** Supervisor Dan Bonamie provided his updated report. New Construction for spring with homes. Planning commission will have public hearings in the future for zoning changes.
  - 3. DPW. Need to get quotes for transfer site for possible paving.
  - **4. Zoning.** No Report was provided.
- **5. Board Members.** Trustee Doug Yanniello asked to correct his comment from the last meeting. First, he explained he cannot write or type with R.A and Osteoarthritis. He misspoke in the last meeting regarding his motion. Not only were they his word, but he had it typed up. The Attorney Greg Meihn 's involvement was only limited to reviewing the motion when he arrived

for the board meeting as to it being in the proper form.
