#### Reports:

1. Fire Department-Report given by Chief Doug Bourgeois.

In March 2023, the Beaver Creek Fire Department was busy attending to the following:

- BCFD responded to 35 Requests for aid, with 1 request for mutual aid assistance to Grayling.
- March training was MIOSHA pt 74 respiratory protection, P.A. 207 the Michigan Fire Code, and NFPA 1500 Firefighter Health and Safety.
- We had four confined space standby at Bakelite and one at Weyerhaeuser.
- Two firefighters have completed their EMT class and are waiting to take the national registry exam. Two Firefighters are currently in Ride-Along at Frederic fo the EMT class.
- A pump issue was fixed on E-2
- Still waiting on repayment form Menominee, and Arauco
- Chief Bourgeois wrote a grant for SCBA packs. The grant was a regional grant for 101 SCBA backs with 10 being for BCFD. Our cost if awarded would be approximately \$7,800 for ten packs.
- We have one officer taking the Fire Instructor class.
- The Grass Rig G-751 will be put back in service at the next training.
- Two firefighters took the VFIS class and passed. Now certified to drive all apparatus.
- Chief Bourgeois attended the Crawford County Chiefs Meeting.
- 2. Supervisor- Dan Bonamie and Lee Riley attending MTA Conference in Grand Traverse April 17, 2023
- 3. DPW- Dan Bonamie advised Tim will be putting the swings and water mid-May and graded the transfer site.

- 4. Zoning-Sandy Beaudet advised Planning commission getting ready for public hearings for updates to the zoning and commercial properties. Atlas Tower was asking permission on 6-mile Rd and Old 27 to put up a tower. Planning Commission denied the area and requested they come back with another area of the 8 properties that said Yes.
- 5. Board Comment- Lee Riley asked if paving the transfer site would be an option sometime. Louis Lucido asked for a UPS drop box at the office and was asked to look into the options. Dan Bonamie is getting ready to set dates for budget workshop and final for the fiscal year.
