AGENDA:

Motion by Little and seconded by Van Nuck to approve the agenda as presented. All ayes, motion carried.

MINUTES:

Motion by Little and seconded by Raybuck to approve the minutes to the January 10, 2017 regular meeting. All ayes, motion carried.

FINANCIAL REPORT:

Motion to accept the financial Report and to look at the corrected amounts. Raybuck asked to abstain from vote as she had not been sent the report. All ayes: 4, abstained 1. Motion passed.

OLD BUSINESS:

- 3. The attorney has review the zoning changes and now it will go back to the PC for a public hearing on March 7^{th} .

 - 4. Add to rules for hall rentals, Benefit Dinner and what is charged for. Put on next month's agenda.
 - 5. 11:00 am. Motion by Little and second by Meisner to go into closed session for purpose of receiving attorney privileged information and regarding a potential claim against the township. Roll call vote with all ayes, motion carried.
 - 11:45 am. Back into regular session.
 - 6. Motion by Hartman and seconded by Van Nuck to have the attorney convey to terminated employee that we will provide medical coverage thru February 28, 2017 and provide one weeks regular pay, in return for execution of severance agreement. Roll call vote with all ayes: Van Nuck, Raybuck, Meisner and Hartman. Nay: Little. Motion carried.
 - 7. Motion by Little and seconded by Meisner to hire Arron Pryar as a part time fire man, subject to passing the requirement of the fire department. Roll call vote with all ayes, motion carried.
 - 8. Motion to move meeting times to 7:00 pm, March through November. Roll call vote: Aye: Van Nuck, Meisner. Nays: Little, Raybuck, Hartman. Motion fails.
 - 9. Supervisor stated that she had made the decision to send the Treasurer to a class without board permission, as it had been discussed previously and not approved.
 - 10. Looking at way to identify picnic tables as Property of Beaver Creek Township.
 - 11. Motion by Hartman and seconded by Raybuck to pass the Resolution to Amend the budget as presented. All ayes, motion carried.
 - 12. Motion by Van Nuck and seconded by Meisner to pay the accounts payable in the amount of \$22,755.25, checks #31168 thru #31215. Roll call vote with all ayes, motion carried.
