- BCFD responded to 28 Requests for aid, with no requests for mutual aid assistance.
- November training was Thermal Imaging camera (TIC) training and two walk-through on-site review of Cogen and Arauco.
- We had one at Georgia Pacific and one at Weyerhaeuser.
- BCFD was very busy on the expressways with over 20 hours spent on three tractor Trailer accidents.
- BCFD is still trying to locate an engine for the military razer side by side from the DNR.
- The Firefighter 1&2 class will be starting in early December and running until the middle of May. I should have three firefighters taking the course.
- Chief Bourgeois attended the Roscommon and Crawford County Chiefs meeting. Items discussed were MABAS, county wide training, and county wide medical.
- Rescue 740 and Grass 751 are back in service. All apparatus is in service and running well.
