Split zoned CSC/LDAR Property Size 659x1321- 20 Acres. Highway Service Commercial for entire property for SDF Storage Facility.

Representative Lapham Associates for Mr. Rostas gave his proposal to have zoning changed to approve a storage facility.

Zoning officer Supervisor Dan Bonamie read several letters from the surrounding residents within 300 feet of the parcel in question that they do not want a storage facility and would like to keep the zoning as is.
