1. Fire Department: Report was read by Heather Hatfield.

In September 2022, the Beaver Creek Fire Department was busy attending to the following:

- BCFD responded to 23 Requests for aid, with no request for mutual aid assistance, and one assist from Grayling Fire Dept.
- September training was a pre-plan walk through at Bakelite and Cogen with Grayling Fire Departments and a Hazmat Awareness Training.
- We had Five confined space standby at Bakelite and two at Weyerhaeuser.
- BCFD hosted two trainings for Weyerhaeuser at BCFD. Training was for their Fire Brigade and consisted of hose advancement, nozzle use and fire extinguisher use.
- Chief Bourgeois attended the Emergency Service Meeting, MABAS Meeting and Inspector training in September.
- Five Firefighters have been enrolled EMT classes, two at Frederic and three at Denton. Classes will run until April.
- FF Beaudet and Chief Bourgeois attended the Michigan State Fireman's Association Golf outing at Grayling Country Club. The trophy is on display at the fire station.
