This includes Fire, Parks and Hall with Liquor and Cemetery. Tax season is over, all unpaid taxes are officially delinquent and have been sent to Crawford County. Supervisor Dan Bonamie motioned to accept the report with auditors' approval.
- 2. Crawford AuSable School District Superintendent Justin Gluesing presentation on May 3, 2022 Bond Election Projects on Middle School, Elementary and High School
- 3. Supervisor Dan Bonamie moved to appoint Brian McPhail to Planning Commission board with support from Treasurer Heather Malone. All Ayes, motion carried.

Reports:

1. Fire Department report was given by Chief Doug Bourgeois.

In February 2022, the Beaver Creek Fire Department was busy attending to the following:

- BCFD responded to 27 Requests for aid, with 2 requests for mutual aid assistance to South Branch.
- February training was Incident Command Training.
- We had three confined space stand-by with one at Weyerhaeuser and two at Georgia Pacific in February.
- A letter was sent to Representative Jack Bergman who may be able to help BCFD locate an engine for the military razer side by side from the DNR.
- Our three firefighters are doing great at the Firefighter 1&2 classes.
- Chief Bourgeois meets with the new safety representative from Weyerhaeuser concerning teaching OSHA required classes to their Fire Brigade.
- The Firefighter banquet is over. Thanks to the Firefighters and Township personnel who attended.
- Chief presented a grant for \$100,000 for a training building. The grant is from the State of Michigan, with no match.
- Chief Bourgeois attended a three-day inspectors conference in Mt. Pleasant.
- Lt. Morrow and PFF Beaudet Watered down the sledding hill for Winterfest.

• We had two Firefighters injured on the Williams Trail Fire. This was a 5-alarm fire. The temperature was -24 degrees, and we were on scene 9.5 hours. Seven engines from various departments froze throughout the event.

Zoning- one permit for new business special use reupholstering in part of garage.

DPW- transfer site using less than half since recycling has gone in.

Board Comment-Supervisor Dan Bonamie advised board that the planning commission turn down the Federal Hwy request to re-zone area for storage units. The campground permit for Military Road residents has been tabled for the next meeting. Small leak in hall is being addressed and our lawnmower is 10-year-old and looking for a replacement. It is out of commission with several thousand to repair.

Public Comment- South Graying Road complaint of road falling apart like Fletcher Rd. if we can contact the road commission.

Chief Doug Bourgeois commented on the Pipeline Industry training at the Ramada in Grayling March 16, 2022 and invited the Board members to attend.
