TREASURER'S REPORT:

Motion by Little and seconded by Summers to accept the Treasurer's Report as presented. All ayes, motion carried.

CLERK'S REPORT:

Next election will be in August.

SUPERVISOR'S REPORT:

The supervisor has attended meetings of the Crawford County Road Commission and Crawford County Supervisor's Group. The Board of Review has another meeting on Thursday. Also he has helped set up a meeting of residents from Section 22 regarding an emergency plan if there are future gas leaks.

HIGGINS LAKE UTILITY AUTHORITY:

Nothing is happening on the proposed cell tower. Gary Fox was present to update the board on a grant that is being written to help with sewers around Higgins Lake.

- 2. Discussion regarding recent snow storm and snowplowing at the transfer site and township hall. Motion by Summer and seconded by Hartman to start the purchasing process for a 4 wheel drive pickup, not to exceed \$8,000. Roll call vote with all ayes, motion carried.
- 4. Request from Youth Booster Club for a contribution for fireworks. It will be on the April agenda when we have had time to look at the budget for the next fiscal year.
- 5. Motion by Little and seconded by Summer to spend \$79.00 for a MTA class for the clerk. All ayes, motion carried.
- 6. Motion by Hartman and seconded by Little to transfer \$1,000 to line item Zoning Legal from Unallocated. Roll call vote with all ayes, motion carried.
- 7. Motion by Ashton and seconded by Hartman for Little to work on a policy regarding attorney use. All ayes, motion carried.
- 8. Motion by Ashton and seconded by Hartman to pay the Accounts Payable invoices in the amount of \$16,471.94, check #26964 and checks #26984-#27026. Roll call vote with all ayes, motion carried.
