- 3. Wage Scale/Meeting Dates. Motion by Van Nuck and seconded by Raybuck to approve with three changes: change the Maintenance Labor, Cleaning and Newly hired Maintenance /Substitute Secretary from \$10.30 to \$10.50 per hour. Roll call vote with all ayes, motion carried.

- 8. MTA. Clerk questioned if board wanted anything added to the yearly dues to MTA in the form of classes, etc. No.

Here is the board report for the July 2020 Township Board Meeting with the June 2020 statistical fire report. Please feel free to call me if you have any questions.

In June 2020 The Beaver Creek Fire Department was busy attending to the following:

- Because the Covid-19 precautions are still in place we at the fire department will continue with the below precautions until August 1st 2020.
 - o Instituting the PPE precautions advised by CDC, North Central Med. Control, International Fire Chiefs, Michigan Emergency Management and numerous others while responding on emergency medical runs.
 - Full PPE and limited patient contact on all runs.
 - Limiting the number of working staff at the fire department.
- All Crawford County fire departments have returned to "normal" operations the first week in June.
- The overall hours of coverage at the station is back to pre-COVID days.
- BCFD responded to 38 Requests for aid with four of the requests being a mutual aid structure fire to Grayling Fire.
- June training was pump operations, search and rescue and water supply operations.
- We had 6 Confined Space Stand by with 2 at Georgia Pacific, 3 at Weyerhaeuser and 1 at Hawk Hill Farms for a horse competition.
- The 2020 Crawford County Firefighter 1&2 Class tested on June 12th and 13th 2020 with Chris Kukulski passing both his written and practical.
- The new rescue vehicle R-740 is working great.
- The A.F.G. grant was submitted last month for extrication tools. With everything going on I expect a longer than usual time frame for awards to be announced.
- We have started construction on the training area. We are waiting on a structural engineer to come out and evaluate the construction plans. We will be using the funds from the Firefighter Training Counsel of \$18,500 for training equipment and training facility up-grades.
- The bay floors are done. Lt. Miller did a great job supervising the completion of that project. .

From Michigan Bureau of Elections Section 57 Campaign Finance, on election day, Michigan Election Law prohibits campaign materials and campaigning within 100 feet of the entrance to any polling place (MCLs168.744 and 168.931). This includes unattended vehicles with campaign signs parked on township property.

A slate of candidates can be attended by one person outside the 100'.

Motion by Meisner and seconded by Raybuck to rescind the existing Beaver Creek Township Policy for Campaigning on Township Property/Campaign Signs and require a new policy that complies with MCLs168.744 and 168.931 to be written by attorney. Roll call vote with 4 ayes, 1 absent. Motion carried.

Discussion regarding holding our next meeting together or virtual. To protect the township, we will do it virtual and it will take place Monday, July 27, 2020 at 9:30 am.
