The Beaver Creek Township Board held its regular meeting was held on Tuesday morning, July 14, 2015 at 10:00 am. The board members present: Ashton, Hartman, Van Nuck, Little and Riley. There were 20 visitors present.

Motion by Little and seconded by Riley to accept the agenda, and add Sharon Priebe, County Commissioner, under Guest Speaker.

Motion by Little and seconded by Van Nuck to approve the minutes from the June 9, 2015 meeting. All ayes, motion carried.

## Treasurer's Report:

Motion by Riley and seconded by Little to accept the treasurers report as presented. All ayes, motion carried.

## Clerk's Report:

There will be a Crawford AuSable School Election August 4<sup>th</sup>. The hearing on the zoning changes will be held by the Planning Commission on August 4<sup>th at</sup> 7:00 pm during their regular meeting. Policies are being worked on.

# Supervisor's Report:

- 1. Working on Donation Agreement for property on South Grayling Road from Wells Fargo.
- 2. Tire Cleanup filled one semi.
- 3. Working on the Beaver Creek Township/Grayling Charter Township Utilities Authority.

#### **Higgins Lake Utilities Authority:**

Ron Wood stated that the Authority is asking residents to not drive over the sewer lines in the winter.

# Fire Department:

Everyone has heard about the rollover tanker accident. We have a tanker on loan from South Branch Township and looking at options to replace the wreaked tanker. The steel has been purchased to replace the roof at the fire department. The firemen have attended the Fire Wise Program two days last week. Looking at county wide Fire Fighters I and II classes.

## Commissioner, Sharon Priebe:

According to State Ordinance, a dog in county custody has to be held and not destroyed until you get permission from the owner. Van Nuck and Priebe are working to get new laws in place regarding moving issues along when you have a dog that is unsalvageable and in the county shelter.

## DPW:

All programs and equipment has been transferred to the township offices, to do with the transfer site. Waste Management did not pickup of garbage, as requested, which left us with putting garbage on a tarp on July 5<sup>th</sup>.

# PLANNING/ZONING:

The zoning administrator has been working on several blight issues and the township has issued over \$800,000 in new permits, the latest being a new roof at Weyerhaeuser. Motion by Ashton and seconded by Van Nuck to send the zoning administrator to training in Frankenmuth on August 11<sup>th</sup>. Roll call vote with all ayes, motion carried. - 5. Motion by Van Nuck and seconded by Little to accept the General Appropriations Act Resolution 2015-2016. Roll call vote with all ayes, motion carried.
- 6. Motion by Van Nuck and seconded by Little to accept and pay the Worker's Compensation policy effective 7/1/2015. Roll call vote with all ayes, motion carried.
- 7. Motion by Riley and seconded by Van Nuck to put a "For Sale" sign at 10100 S. Grayling Road, the property given the township by Wells Fargo, and to set the sales price at \$15,000. Ayes: 5, motion carried.
- 8. Motion by Little and seconded by Van Nuck to honor the request of the DNR for a Letter of Support regarding the Off-Road Vehicle Connector Routes in our township. Roll call vote with all ayes, motion carried. The requested Off-Road Vehicle Connector Routes letter will be returned to the DNR with proper signatures. Amy from the DNR answered questions from residents.
- 9. Motion by Little and seconded by Riley to pay the Accounts Payable in the amount of \$39,716.86, checks #29854 thru #29901. Roll call vote with all ayes, motion carried.
