### BEAVER CREEK TOWNSHIP EMERGENCY SERVICES COST RECOVERY ORDINANCE #55

#### PREAMBLE

Beaver Creek Township and its Fire Department desire to provide a process for the Fire Department to recoup costs and fees incurred by the Fire Department in providing emergency fire service, inhalator service and emergency ambulance services alone or jointly with another municipality to non-domiciled-residents.

#### PURPOSE-ORDINANCE

The purpose of this Ordinance is provide the right of the Board to establish by resolution from time to time charges for emergency services provided to non-domiciled-residents 33 PA 51 as amended [MCL 41.80 1ff and MCL 5.2648 ff and MCL 41.806 Sec 6a] and to provide a methods for collection of such charges as determined by the Board by resolution from time to time.

#### SECTION 01: REGULATIONS

A. This Cost and Fee Recovery Ordinance is authorized by MCL 41.806a Sec. 6a which provides as follows:

Sec. 6a. The legislative body of a municipality providing emergency police or fire service or the legislative bodies of municipalities acting jointly to provide such a service pursuant to this act may authorize by ordinance the collection of fees for the service. The township board of a township or the county board of commissioners of a county providing emergency ambulance and inhalator service alone or jointly with another municipality and the legislative body of such a municipality may authorize by ordinance the collection of fees for the service.

B. Whenever Beaver Creek Township Fire is dispatched by Crawford County Central Dispatch (911) to provide emergency fire service, inhalator service and emergency ambulance services alone or jointly with another municipality to non-domiciled-residents, the non-domiciled-resident shall pay for such costs and fees as set forth below:

a. Engine	\$500.00 per incident
b. Tanker/Tender	\$350.00 per incident
c. Rescue	\$350.00 per incident
d. Snowmobile	\$150.00 per incident
e. Manpower	Regular Hourly rate
Other costs occurred	Cost to replace

Beaver Creek Township shall review the costs referenced above each year and shall, by Resolution, set new costs as determine in its sole discretion.

**SECTION 02: VIOLATIONS AND PENALTIES**

Any person who fails to comply with this Ordinance and the payment of costs as determined above, from time to time by the board, shall be deemed to be responsible for a municipal civil infraction as defined by Michigan Statute, Punishable by a civil fine determined in accordance with the schedule; ORDINANCE #27.

**SECTION 03: SEVERABILITY**

The provisions of this ordinance are hereby declared to be severable and if any clause, sentence, word, section or provision is declared void or unenforceable for any reason by any court of competent jurisdiction, it shall not affect any other portion of this ordinance.

**SECTION 04: REPEAL**

The Ordinance #55 repeals those parts of Ordinance #34 of Beaver Creek Township and all parts that are in conflict with this Ordinance.

**SECTION 05: EFFECTIVE DATE**

This Ordinance shall take effect 30 days after publication as required by law.
